**Sub : Mode of Selection of Transaction Advisors (TA) for PPP Projects
(Circular No. 23)**

Department of Economic Affairs (DEA), Ministry of Finance, Government of India had notified a panel of 11 TAs for offering consultancy support in PPP projects. The same had been endorsed and adopted by Government of M.P. vide Circular dated 09-09-2008 (Circular No. 11) and Circular dated 18-09-2007 (Circular No. 7). It was recommended that TAs for PPP projects may be appointed by inviting financial offers from amongst these 11 TA firms.

DEA, vide letter dated 30th April 2012, has withdrawn the said panel of TAs (copy of letter is attached). **Hence, all departments/agencies/undertakings of Government of Madhya Pradesh planning PPP projects are henceforth recommended to appoint TAs through a transparent open competitive process.** They are advised not to directly invite bids from the erstwhile DEA panel endorsed and adopted by Government of M.P.
