Sub : Submission of Data on PPP Projects to PPP Cell (Circular No. 25)

Directorate of Institutional Finance (DIF) is the Nodal Agency for PPPs in Madhya Pradesh. The PPP Cell under the DIF maintains the database of PPP projects in the State in all stages of development/implementation. With a view to ensuring consistency in the database, it is hereby requested that data updates on projects be submitted to the PPP Cell as follows:

- Projects Completed (Operational) : Copy of Completion Certificate duly issued to the Concessionaire by the Implementing Agency
- Projects Awarded (in Construction Stage) : Copy of LoA (Letter of Acceptance) and copy of Concession Agreement executed between the Implementing Agency and the Concessionaire (signed version of the copy)
- Projects in the Planning Stage (Under Bidding/Pipeline) : Copy of approval of SLEC/DLEC, as applicable

Both soft as well as hard copies of the records are to be submitted. This above provision is in addition to the existing Monthly Reporting System being followed for PPP Projects (vide Circular of Finance Department, Government of Madhya Pradesh No. F-1/42/04-PMU/2011/1272 dated 20 April 2011) as per which monthly progress of PPP projects is to be submitted to the PPP Cell by the 7th of each month.

All departments/agencies/undertakings of Government of Madhya Pradesh undertaking PPP projects are requested to adhere to the data-submission requirements stated above, failing which their projects may not appear in the State PPP database. This provision applies for ongoing as well as projects put up in pipeline.
